## About this course

### Are you looking for a career talking to the animals?

When you complete the Certificate IV in Veterinary Nursing you will be ready for a career as a veterinary nurse, or animal welfare worker.

You will have the skills and knowledge to work effectively in a veterinary practice, providing care to a wide variety of animals, assisting with surgery preparation and procedures, performing pathology and imaging procedures, providing post-surgery care and advice, and workplace safety and health.

This course is popular and highly competitive to get into. Please ensure you enter all your work and work experience, both related to the field and unrelated, in your application.

Part time studies - this course is offered on a part time basis but has only one intake per year. Application for part time studies open in September each year. Part time studies consist of 1 day per week attendance and you would be required to undertake work experience 1 day per week in industry. Students must organise their own work placement before they apply.

The course is also offered via Correspondence but only available to students residing outside the metropolitan area. Correspondence students must have a veterinary practice organised for work experience.

## VET Student Loans

Selected courses are VET Student Loan eligible courses.

A VET Student Loan creates a debt that must be repaid to the Commonwealth and is only available to students who are eligible.

## Apprenticeships and traineeships

Fees for apprenticeships and traineeships are charged at a rate per nominal hour of study.

This means that your fees will vary depending on the units you study as part of your training plan.

Apprentices and trainees are liable to pay for their own fees but some industrial agreements (awards) dictate that employers are required to reimburse their apprentice upon receipt of satisfactory progress. An employer may also opt to pay on behalf of the apprentice or trainee.
